

MARYMOUNT CAR RAFFLE 2019

TERMS AND CONDITIONS

The Promoter:

The Promoter is Marymount University Hospital and Hospice registered charity number CRA 20000509.

The Prize(s):

The first prize is one right-hand drive Toyota Corolla Hybrid Luna valued at €29,500. There is no cash equivalent in place of the car. The Promoter accepts no responsibility or liability to winner for any dissatisfaction with the prize.

Marymount wish to acknowledge the kind assistance of Cogans of Carrigaline in supplying the vehicle at a discounted price and supplying demo vehicles to market the draw.

The Raffle Draw:

Entry to the draw is by means of raffle ticket specially commissioned by the Promoter. The Raffle Draw is open solely to those who have purchased a Marymount raffle ticket. All duly completed raffle tickets purchased between 1st April and 1st December 2019 will be entered into the draw. Raffle tickets are priced at €10 or 3 for €20. By purchasing a ticket, entrants will be deemed to have agreed to be bound by these rules.

How to participate:

Each ticket purchased has a unique code printed on it and entitles the purchaser to register one entry into the draw. You must retain your ticket as proof of purchase.

Winner selection/how to claim:

The winning ticket will be drawn by an independent adjudicator appointed by the Promoter for that purpose on 1st December at Marymount Hospice and the winner will be notified personally as soon as possible on this date, and if not contactable, after this date. The promoter will use reasonable endeavours to contact all winners using the contact details supplied upon. If a winner does not claim or respond within one calendar month of the closing date, the winner forfeits the right to claim the prize.

Players who buy tickets online must fill out all details requested to facilitate contact should they be drawn as a prize winner.
